



# Pond Walking Trail




- Estimated Cost: \$100,000
- Details: 1/2 mile long, 9ft wide, 5 inches deep, with two pedestrian bridges over drainage areas.
- Timeline: Project would be completed by Spring 2015

# Additional Playground



- Estimated Cost: \$23,000 (\$35,000 w/Shade Cover)
- Details: Designed for kids ages 2-5
- Timeline: 6-8 Weeks from date of approval

## **Enclosed Clubhouse**



- Estimated Cost: \$200,000\*
- Details: One large room, dividable into two, kitchen area and conference room.
- Timeline: 8-12 Months from approval.
- \*Approval of this project is contingent upon funds from Springfield HOA
